The meeting took place in the Municipal Building located at 1 New Market Street at 7:00 p.m. The meeting was opened with the Pledge of Allegiance. Council President announced that a quorum was present. Also in attendance were Mayor Charles Washington, Jr., Solicitor David Puma, and City Clerk Kathleen L. Keen. Councilman Vaughn Groce was absent. CFO David Crescenzi joined the meeting at 7:10.

#### RESOLUTION 2015-134 A RESOLUTION CERTIFYING THE 2014 ANNUAL AUDIT

**WHEREAS,** N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

**WHEREAS,** the Annual Report of Audit for the year ended December 31, 2014 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, <u>R.S.</u> 52:27BB-34 authorizes the Local Finance Board of the State of New to prescribe reports pertaining to the local fiscal affairs; and

**WHEREAS**, the Local Finance Board has promulgated <u>N.J.A.C</u>. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled Findings and Questioned Costs; and

**WHEREAS**, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled Findings and Questioned Costs, as evidenced by the group affidavit form of the governing body attached hereto; and

**WHEREAS**, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

**WHEREAS**, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS,** failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

<u>R.S.</u> 52:27BB-52 - A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office."

**NOW, THEREFORE BE IT RESOLVED**, that the Mayor and City Council of the City of Salem, hereby states that it has complied with <u>N.J.A.C</u>. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

#### **COMMITTEE REPORTS**

**Administration:** President Roots no report; the next Administration meeting will be October 13<sup>th</sup> at 5:30.

**Public Safety:** Councilman Gage no meeting to report, though a police officer did submit a resignation.

**Public Works:** Councilman Groce was absent; Councilman Gage reported work on "mud diggers ditch began today".

**Community Service:** President Roots no report; the next Community Services meeting will be held on October 13<sup>th</sup> at 6:00.

**Human Services:** Councilman Hassler no report.

**City Property/Capital:** Councilwoman Carter no report; the next meeting will be October 13<sup>th</sup> at 6:30.

**Redevelopment:** Councilman Waddington reminded everyone of the SUFS dinner on October 14<sup>th</sup>. He noted at the redevelopment committee meeting SUFS expressed interest in the properties the city will receive from the recent In Rem foreclosure. He spoke of a joint meeting with the Historic Preservation Committee recently to discuss the Architectural Survey report. Lastly he mentioned a property that backs up to the Olive Street Garden that needs attention. The next meeting will be held on October 19<sup>th</sup>. President Roots asked if he spoke with his committee regarding extending the Historic District east to Yorke and Keasbey Streets and west to Front Street. Councilman Waddington noted there was some discussion. He also asked if council would like to have Watson & Henry Architect's present their findings/report. President Roots acknowledged and informed Councilman Waddington to please schedule.

**Neighborhood Initiatives:** Councilman Johnson no report. Councilman Hassler noted the Salem City Community United Group recently cleaned up a property on East Broadway, and did a fabulous job; noting the supplied a dumpster, and the City Trailer was also provided for their use.

#### **PROCLAMATION:**

Mayor Washington read the following proclamation.

### PROCLAMATION PUT THE BRAKES ON FATALITIES DAY OCTOBER 10, 2015

October 10, 2015, has been declared Put the Brakes on Fatalities Day by the Common Council of the City of Salem in the County of Salem, and the State of New Jersey;

**WHEREAS,** Across the nation, traffic crashes caused approximately 32,675(est.) fatalities in 2014, and are the leading cause of death for young people ages 15 to 34; and,

WHEREAS, In New Jersey, 556 individuals lost their lives in traffic crashes in 2015; and,

**WHEREAS**, Alcohol-related crashes accounted for 27.0 percent of the State's traffic fatalities, while 26 percent of all fatal crashes involved traveling at unsafe speeds; and,

**WHEREAS**, Motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and,

**WHEREAS**, 60 motorcyclists, 11 bicyclists and 170 pedestrians were killed in New Jersey in traffic-related crashes in 2015; and,

**WHEREAS,** Safer driving behaviors such as buckling up, every ride; obeying posted speed limits; stopping for pedestrians in crosswalks and using crosswalks when walking; avoiding aggressive driving behaviors; never driving impaired; wearing proper safety gear while riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths;

**NOW, THEREFORE**, the Mayor and the Common Council of the City of Salem, in the County of Salem and State of New Jersey do hereby proclaim **October 10, 2015**, **Put the Brakes on Fatalities Day**, and call upon everyone to put these lifesaving behaviors into practice to improve safety on the roadways in our community and throughout the State.

Officially recorded this 5<sup>th</sup> day of October in the year of our lord two thousand fifteen.

#### **MAYORAL COMMENTS:**

Mayor Washington thanked Everet Dickerson for delivering the Invocation this evening, reiterating the City Council will continue in this direction at all meetings. He talked about the curfew hours for Halloween, and the ongoing Downtown Beautification project on Broadway. Lastly he spoke of abandoned properties within the city.

**NEW BUSINESS:** CFO Crescenzi spoke about the Best Practices Checklist, informing Council he would be handing them out for their review. Councilman Gage reminded everyone to RSVP to the Fireman's Ball, and discussed the possibility of another CLG Grant to help with the work needed at 1 New Market Street.

#### **PUBLIC PORTION:**

<u>April Dorsey-Crossing Guard for the City</u> addressed council about issues she has had with parents and children while at her job. She spoke of a recent incident she feels could have been handled better by the police department. She has resigned her position, and is now being denied unemployment. President Roots, asked Councilman Gage, Mayor Washington, and Chief Pelura to schedule a meeting with Ms. Dorsey.

<u>Rod Miller of W. Broadway</u> asked when his block would be deemed historic and included in the historic district. President Roots and Councilman Waddington responded to Mr. Miller explaining the process to him. Councilman Waddington noted it will be looked into. Mr. Miller then asked who the council liaison to the Housing Authority was; stating West Side Court is full of trash. Council President Roots noted it was Mr. Groce whom was absent this evening.

With no further requests for public comment, Councilman Hassler made a motion to close the Public Portion of the meeting. Councilman Gage seconded the motion and all were in favor. Councilman Hassler motioned to convene into Executive Session, Councilman Gage seconded the motion and all were in favor. The regular portion of the meeting ended at 7:45pm.
