**WHEREAS, Keith Bonchi, Esq. of the firm of Goldenberg, Mackler, Sayegh, Mintz, Pfeffer, Bonchi and Gill ( hereinafter “ the firm” ) has submitted a proposal dated April 16, 2018 indicating they will provide the services for the hourly rate of \$250.00 for attorneys, \$125. Per hour for paralegals and \$75.00 per hour for legal assistants; and**

**WHEREAS, the firm has completed and submitted a Business Entity Disclosure Certification which certifies that Goldenberg, Mackler, Sayegh, Mintz, Pfeffer, Bonchi and Gill has not made any reportable contributions to a political or candidate committee in the City of Salem in the previous one year, and that the contract will prohibit the firm from making any reportable contributions through the term of the contract, and**

**WHEREAS, the CFO has certified that funds are available.**

**NOW THEREFORE, BE IT RESOLVED** that the Common Council of the City of Salem authorizes the Mayor to execute a contract with Goldenberg, Mackler, Sayegh, Mintz, Pfeffer, Bonchi and Gill as described herein; and,

BILL A3724/SENATE BILL S2313 INTO LAW ESTABLISHING THE  
ZERO EMISSION CERTIFICATE PROGRAM FOR NUCLEAR POWER  
PLANTS**

**WHEREAS**, the City of Salem recognizes the benefit that the PSEG Nuclear LLC power plant has been to the County of Salem, by contributing millions to the local and regional economy , supporting 5,800 jobs with 1,600 direct jobs at the plants, many of those employed being from the local area; and

**WHEREAS**, City Council recognizes that the power plants have proven to be good neighbors dedicated to safe operations and supporting may volunteer and non-profit organizations within our region’s community; and

**WHEREAS**, the City Council desires to see the nuclear power plants continue to be viable Zero Emission Energy providers, protecting our environment by supplying more than 90 percent of New Jersey’s carbon free electricity for 3 million homes.

**NOW THEREFORE BE IT HEREBY RESOLVED** by the Common Council of the City of Salem, County of Salem and State of New Jersey, that it does hereby urge Governor Phil Murphy to sign the Zero Energy Emission Certificate Program for nuclear power plants legislation

**BE IT FURTHER RESOLVED** a copy of this resolution be forwarded to Governor Murphy, Senate President Sweeney and Salem County municipalities.

Mr. Johnson went out to assess the pool and stated that nothing major needs to be done. Stated that a few spots need to be done concerning the concrete. There is paint left over from last year that will be used. Ms. Roots is looking to have more recreational events for the kids at the pool site.

**City Property/Capital/Human Services: (Carter, Walker, Kellum, Roots)**

Sean from Remington and Vernick stated that they are waiting for a schedule for the next demos to be done. Awaiting information from the contractor. Mr. Dilks from library board stated that they would like to own property next door to the library. Has been in contact with owners and has come to a verbal agreement. Discussion will be made by the committee at a later date. In addition, Ms. Roots stated that she is looking to open pool around Jun 28, 2018.

Lastly, Spring Cleanup will commence on Saturday, May 19 from 8:00am-12:00pm. Mr. Johnson will also discuss bulk drop at next meeting.

Cheryl Turner- Stated that she would like to see the children use the track for their benefit. Council Roots addressed her question.


Motion made by Councilman Gage and seconded by Councilman Johnson to close public portion. All in Favor. Motion carries.
