# CITY OF SALEM MINUTES OF THE COMMON COUNCIL SPECIAL BUDGET MEETING OF MARCH 9, 2015

A Special Budget meeting of the Common Council of the City of Salem was called to order by Council President Karen Roots. The meeting took place in the Municipal Building located at 1 New Market Street at 4:30 p.m. The meeting was opened with the Pledge of Allegiance. Present: Council President Karen Roots, Councilpersons, Ruth Carter, Earl Gage, Vaughn Groce, Charles Hassler, and James Waddington. Council President announced that a quorum was present. Also in attendance were City Solicitor David J. Puma, CFO David Crescenzi, and City Clerk Kathleen L. Keen. Mayor Washington and Councilmen Sherman Hampton and Horace Johnson were absent.

### STATEMENT OF THE OPEN PUBLIC MEETINGS ACT

The discussion then turned to landlord licenses, CO's and non-payment of taxes; people walking away from homes and the loss of jobs within the city recently with Ardaugh closing and relocation of Wire Pro. Lastly CFO Crescenzi questioned what dollar amount applying for and the narrative for the transitional aid application.

following conditions: (1) the application for aid is withdrawn; (2) notice is received that no award of funds will be provided in 2015; or (3) consistent with the terms of the/an MOU are required to be executed as a condition of grant award.
