The meeting took place in the Old County Courthouse located at Broadway and Market Street at 7:00 p.m. The meeting was opened with the Pledge of Allegiance. Present: Council President Karen Roots, Councilpersons, Ruth Carter, Earl Gage, Vaughn Groce, Charles Hassler, Horace Johnson and James Waddington. Council President announced that a quorum was present. Also in attendance were Mayor Charles Washington, Jr., Solicitor David Puma, CFO David Crescenzi, and City Clerk Kathleen L. Keen. Councilman Sherman Hampton was absent.

- 1. That the attached list shall constitute the emergency temporary appropriations for the budget year of 2015.
- 2. That said emergency temporary appropriations will be provided in the 2015 budget as presented in proceeding.
- 3. That three certified copies of this resolution be filed with the Director of Local Government Services.

# **COMMITTEE REPORTS**

**Administration:** President Roots reported the next meeting will be May 12th at 5:30; in her absence Councilman Waddington will oversee the meeting.

**Public Safety:** Councilman Gage reported the committee has had a series of meetings regarding the manpower of the police department.

**Public Works:** With Councilman Hampton absent, Councilman Groce reported on the Elkinton Dam, he noted the committee had met recently with the Mayors of Elsinboro and LAC to discuss the situation with regard to the pump station. Mayor Washington stated he had signed a letter to the state requesting money to help with the dam.

**Community Service:** President Roots gave an update on the progress of the city pool for the upcoming season. The next meeting is scheduled for May 20 at 5:00.

**Human Services:** Councilman Hassler stated the city moving will be looking into a vacant properties ordinance.

**City Property/Capital:** Councilwoman Carter reported on a cement pad to be reconstructed at the Washington Fire House, and the city offices moving back into 17 New Market Street. The next meeting will be May 20 at 5:30.

**Redevelopment:** Councilman Waddington reported the Farmers Market will be opening on June 12<sup>th</sup> at 10:00am. He discussed Cathedral Church moving forward on properties in the city, and the demolition of 15 Olive Street due to it being destroyed in a recent fire. The next meeting is scheduled for May 18<sup>th</sup> at 5:15.

**Neighborhood Initiatives:** Councilman Johnson reported this Wednesday will be trash amnesty day, and Saturday will be bulk amnesty and the city wide clean-up. He noted this will be the third year for the city wide clean-up and there is always a good response. Lastly he stated the city trailer will be available for use on Tuesdays, Thursdays, and Saturdays; the trailer will be signed for and the person will be responsible for it while in their use. Councilman Hassler noted all trash picked up during the city wide clean-up can be bagged and left on the curb for the city to pick up.

# **MAYORAL COMMENTS:**

Mayor Washington stated the council will be having a closed session to discuss and plan for the upcoming summer months. He noted the Abandoned Properties Act of 2014 needs to be addressed here in the city. Lastly he reminded everyone May 11<sup>th</sup> is Salem County night at the Blue Rocks; there are over 100 Salem City Little League players attending, please come out and show your support for the players.

### **NEW BUSINESS:**

City Clerk Keen informed the public of the city offices being moved back into 17 New Market Street, noting the offices will close Tuesday May 5 at 12 noon, closed on Wednesday, and will reopen on Thursday at 8:30am. The City Clerk also noted due to a scheduling conflict, the next Council meeting will be held on Tuesday May 19 at #1 New Market Street.

# **PUBLIC PORTION:**

<u>Lorraine Phillips, Captain of Fenwick Ambulance</u>, questioned Councilman Gage as the liaison for the Public Safety Committee, why there have been meetings and Fenwick Ambulance has not been included. Councilman Gage responded the recent meetings have been solely to address the police department staffing.

<u>Pamela Bateman, Crossing Guard</u>, addressed council regarding her crossing guard position and the abuse the guards take.

April Dorsey, Crossing Guard, noted she had been attacked at her post, suffering a black eye and a concussion; and the abuse continues. She called the police and was told by the police secretary her post was being moved. Ms. Dorsey noted her post is normally 12 minutes from her home, now it is 30 minutes. She stated when she showed up at her post someone else was in her place, when she called the police the officer who came there was very rude to her. Ms. Dorsey also noted many parents were not happy with her being moved, as the children were "used to her there"

<u>Pamela Bateman, Crossing Guard</u>, stated she is a guard at Smith and Walnut Street and is continually harassed, threatened, and was almost run over. She noted they are not just crossing guards, they direct traffic also. She voiced her displeasure with the police and the police secretary also, noting there should be better communication with all. Mayor Washington addressed Ms. Bateman, noting the crossing guards are employees of the city under the direction of the police department and the Chief of Police, she should address the Chief with her concerns.

<u>William Corbin of Davis Avenue</u>, stated the city has lost football coach Thomas to Millville, noting it is a great loss to all. He then spoke of people walking in the streets when there are sidewalks; he said it is getting worse with the warmer weather coming and more people out. He asked if there is a city ordinance regarding this. Mayor Washington addressed Mr. Corbin noting Coach Dennis Thomas leaving is upsetting to all. He also stated jaywalking is enforceable, however residents must "back up" council when this is enforced.

<u>Cheryl Spence of Thompson Street</u> spoke of problems on and around Thompson Street; noting cars were being worked on, there have fires, loud music etc. She asked if working on cars is allowed in a residential area. She stated at night and on weekends the music is very loud, she has called the police, but they do not come. Ms. Spence then asked for a sign to be placed in front of her house regarding the Ordinance for loud music. Lastly she spoke of a party on Olive Street recently with a big screen set up, a lot of people and loud music, voicing her concerns for what the summer season could bring.

<u>Helen Pierson of SUFS/Main Street</u> reported the contractor will be starting the side of the Municipal Building on Tuesday.

<u>Rebecca Gower-Call of Fenwick Ave.</u> thanked council for allowing her to speak at the previous meeting regarding the housing authority.

<u>Rodney Miller of West Broadway</u> referred to a property on the corner of Olive Street as always being a problem, stating the landlord should be addressed about the issues. He then stated council could "shrink" its size to help save money for the city. Councilman Groce noted this has been mentioned before and questioned Solicitor Puma on the process. Solicitor Puma stated he would have to look into it to get the specifics. Mr. Miller then stated the clean-ups are good, but they are continual, the city needs to implement an advertising plan to bring people to the city.

With no further requests for public comment, Councilman Hassler made a motion to close the Public Portion of the meeting. Councilman Johnson seconded the motion and all were in favor.

Councilman Hassler motioned to convene into Executive Session, Councilwoman Carter seconded the motion and all were in favor. The regular portion of the meeting ended at 8:15pm.
