COMMITTEE REPORTS

Administration: President Roots reported Market Street Day was discussed, Councilman Gage presented the committee with a possible MOU for ambulance services, CFO Crescenzi gave an update on the new time reporting system and what is needed to fully implement it. Lastly Councilman Hassler gave an update on the Broadway Beautification Project, and Clerk Keen explained what was happening with the project and forthcoming meetings with the contractor, the state, and the engineer. The next Administration meeting will be September 14th at 5:30.

Public Safety: Councilman Gage thanked Council on behalf of the Police Department for moving forward with the grant for 2 new police cars.

Public Works: With Councilman Hampton absent, Councilman Groce reported the committee has been busy with the water plant, noting the NJDEP was at the plant last month doing test, they identified a few deficiencies in the processes and procedures to be corrected, but nothing with the water.

Community Service: President Roots reported on the pool for the season, and the donations that help keep it running for the children. She noted there are volunteers that will be recognized for all their help. The next meeting will be September 14, 5:30 at 17 New Market Street.

Human Services: Councilman Hassler reported the next free rabies clinic for the city will be in January of 2016. He spoke of abandoned and vacant properties, and gave an update on the Broadway Beautification project.

City Property/Capital: Councilwoman Carter reported on properties that had fires and were currently being demolished. She noted the roof at 17 New Market Street is finished, and now the air conditioning system at 1 New Market Street is not working. The next meeting will be September 14, 6:15 at 17 New Market.

Redevelopment: Councilman Waddington reported the committee is very supportive of CCDC, Java Dog is trying to find a new location in the city, and there is a new restaurant that needs a location also, as the one they were interested in was too close to a church for them to have a liquor license. The Farmers Market is not doing as well as hoped. There is a new worker for Main Street/SUFS Jody Veler will be the Economic and Workforce Development Manager. The next NRTC application is due in October. The next Redevelopment meeting will be September 21, at 5:15.

Neighborhood Initiatives: Councilman Groce said there was a brief meeting last week, they are currently on track for utilizing the trailer and getting properties cleaned up in the city.

MAYORAL COMMENTS:

Mayor Washington informed everyone of what was happening with the Broadway Beautification project; he apologized for the "plates" in the city, noting the city did not intend to have the plates/noise within the city during the farmers market, but it was not our call. Mayor Washington spoke of working on permanent revenue streams for the city, and redevelopment in the port area. Lastly he reminded everyone of the upcoming Literacy Program at the City Pool on August 22nd 11am-2pm.

PUBLIC PORTION:

<u>Robert Lanard of West Broadway</u> said he was very pleased with the Police Department for apprehending three individuals quickly in connection with a beating, a robbery at gunpoint, and an assault. He noted as a resident it feels go knowing the Police Department is getting these people of the streets.

<u>Lucille Simons of Kent St</u> addressed council regarding trash she continually picks up on her street and loitering in her neighborhood at all hours. Ms. Simons said the noise and traffic are constant at all times of the night. Mayor Washington urged Ms. Simons to call the Police Department when she see these things happening, and try to get license plate number of the cars for the police.

Joy Coleman of Van Meter Terrace said she has the same issues in her neighborhood, and would like to have No Littering and No Loitering signs put up. She inquired about the street sweeper for the city, questioned the hiring of two new police officers, and is the police department is fully staffed now. Councilman Gage replied no. Ms. Coleman asked if money was the issue; Councilman Gage replied yes, as well as finding qualified candidates also. Ms. Coleman noted

she would like to see some council members "knock on her door sometime". She questioned the "house ordinances", Councilman Groce explained the houses are in the NRTC zone and will be redeveloped by CCDC. Ms. Coleman asked if Mr. Hampton's position will be replaced, Councilman Gage explained the process.

With no further requests for public comment, Councilman Hassler made a motion to close the Public Portion of the meeting. Councilman Gage seconded the motion and all were in favor. Councilman Hassler motioned to convene into Executive Session, Councilman Gage seconded the motion and all were in favor. The regular portion of the meeting ended at 8:00pm.
