RESOLUTION 2015-132

A RESOLUTION ENDORSING THE CATHEDRAL COMMUNITY DEVELOPMENT CORPORATION "ANOTHER START HOUSING INITIATIVE" PROJECT AND THE APPLICATION TO NJHMFA FOR CHOICE FUNDING IN RELATION THERETO

WHEREAS, the City of Salem desires to approve the development of 4 additional properties as recited in Exhibit A for the development known as the Cathedral Community Development Corporation's "Another Start Housing Initiative" Project to be funded under New Jersey Housing and Mortgage Finance Agency's ("the Agency") Choices in Homeownership ("CHOICE') program; and

WHEREAS, the CHOICE Subsidy will, when applicable, benefit home buyers of the affordable units that will be restricted by the Agency using Uniform Housing Affordability Controls (UHAC) type restrictions with funds to be repaid solely to the Agency at the first unrestricted sale; and

WHEREAS, the CHOICE Subsidy will, when applicable, benefit home buyers of the market priced units that will be restricted by the CHOICE program Emerging Markets Units restrictions, with subsidy funds as the buyers may be required to repay, being repaid solely to the Agency at the first sale; and

WHEREAS, the City of Salem recognizes Cathedral Community Development Corporation as the developer/sponsor of the development; and

- **BE IT THEREFORE RESOLVED** that the City of Salem does hereby support the developer/sponsor's application for such financing and subsidy from the Agency and acknowledges that the processing and expenditure of funds shall be in accordance with the terms of the CHOICE program.
- **BE IT FURTHER RESOLVED** that the City of Salem does hereby commit to this project and shall negotiate an agreement with Stand Up For Salem, Inc. and Cathedral Community Development Corporation to implement the project.

BE IT FURTHER RESOLVED that the Mayor, City Clerk, City CFO, City Solicitor and all City Officials are hereby authorized and directed to take all actions as are necessary to implement this Resolution and that they or their successors in said titles are authorized to sign any documents necessary in connection therewith.

RESOLUTION 2015-133

A RESOLUTION AUTHORIZING THE CITY ENGINNER TO PROCEED WITH A PROPOSAL TO ADDRESS NJDEP MONITORING REQUREMENTS FOR THE CITY LANDFILL

WHEREAS, after engaging in the Fair and Open Process, on or about January 1, 2015 the City of Salem entered into a Professional Services Agreement with Remington & Vernick Engineers ("R&V") for Engineering Services for the City; and

WHEREAS, the City is in receipt of a letter dated July 29th, 2015 from the NJDEP regarding sampling and submission requirements of ground water from the monitoring wells surrounding the Landfill; and a Notice of Violation dated July 22nd, 2015 from the NJDEP regarding the need for an air permit for the passive methane system on the Landfill; and

WHEREAS, the City is in receipt of a proposal dated May 19th, 2015 from R&V to address the foregoing for a cost not to exceed \$9,300.00 to address the foregoing in a timely manner so as to avoid any fines or penalties being assessed against the City; and

WHEREAS, the City's Public Works Superintendents have reviewed the proposal with the Public Works Committee and all are in concurrence with a recommendation that the City Council approve the proposal; and

WHEREAS, the matter has been reviewed with the City's CFO who has confirmed that funds are available in the present budget of the utility for such purpose;

THEREFORE, BE IT RESOLVED, the Mayor and Common Council of the City of Salem, County of Salem, and State of New Jersey hereby authorize Remington & Vernick to proceed with the proposal and the appropriate City Officials are hereby authorized, empowered and directed to: execute the proposal, and/or such other documents as may be approved by the City Solicitor to properly document the same; and take such any and all other such actions as are necessary to proceed with the project.

NOW, THEREFORE BE IT FURTHER RESOLVED, that final authorization and execution of said application is hereby contingent upon final approval by the Director of Local Government Services.
