CITY OF SALEM MINUTES OF THE COMMON COUNCIL MEETING OF SEPTEMBER 21, 2015

A regular meeting of the Common Council of the City of Salem was called to order by Council President Karen Roots. The meeting took place in the Old County Courthouse located at Broadway and Market Streets at 7:00 p.m. The meeting was opened with the Pledge of Allegiance. Present: Council President Karen Roots, Councilpersons, Ruth Carter, Vaughn Groce, and James Waddington. Councilman Earl Gage joined the meeting via conference call. Council President announced that a quorum was present. Also in attendance were Mayor Charles Washington, Jr., Solicitor David Puma, CFO David Crescenzi, and City Clerk Kathleen L. Keen. Councilmen Charles Hassler and Horace Johnson were absent.

STATEMENT OF THE OPEN PUBLIC MEETINGS ACT

COMMITTEE REPORTS

Administration: President Roots reported on a meeting with the State Monitor regarding the MOU, they discussed union negotiations, grievances, and outsourcing. She also spoke of the personnel policy being updated with regard to the dress code, and possible uniform shirts for the Inspections/Housing office workers. Lastly she noted the City Administration Offices are being overrun with Notary Service request. It was decided the services will be for city residents only, and limited to Tuesday and Thursday only, from 9am-11:30 and 1:30-4pm. The next Administration meeting will be September 28th at 5:30.

Public Safety: Councilman Gage absent – no report.

Public Works: Councilman Groce reported on possible water plant litigation. He spoke of reaching out to Ardaugh with regard to the city ordinance and the number of employees needed on site to receive a discount. He mentioned the PCFA grant approval for Mud Diggers Ditch, and an employee retiring in the upcoming year. Lastly he spoke of a resident on Olive Street with an issue, and the Superintendent of the Water plants' correspondence to council.

Community Service: President Roots had no report.

Human Services: Councilman Hassler absent – no report

City Property/Capital: Councilwoman Carter spoke of a request to purchase city owned property in the Tilbury area, however the property is not all city owned, it is partially in Elsinboro. There was a discussion regarding placing liens on properties for grass cutting and boarding up. The next meeting will be September 28, 6:15 at 17 New Market.

Redevelopment: Councilman Waddington reported the committee would be meeting in conjunction with the Historic Preservation Commission this week to discuss the Architectural Survey on Broadway that was recently completed.

Neighborhood Initiatives: Councilman Johnson absent – no report.

MAYORAL COMMENTS:

Mayor Washington thanked Pastor Jones for delivering the Invocation this evening, stating the City Council will continue in this direction at all meetings. He then spoke of the MOU the city is under, noting it will direct the city in the right direction, as the city must meet certain criteria and receive approval from the state monitor before proceeding with any contracts. He noted the city had received prior approval for the purchase of police vehicles. Lastly Mayor Washington apologized for the construction still happening on Broadway; the city never anticipated the project would extend this long. He then reminded everyone of the upcoming "Cow Run" sponsored by SUFS.

PUBLIC PORTION:

<u>Lucille Simons of Kent St</u> addressed council stating Kent Street is not being kept clean, she said most of the homes are rentals and the landlords should be held accountable. The owners keep their properties clean. Mayor Washington addressed Ms. Simon asking her to contact Carol in the Inspections office if there are homes with trash in the yards. Ms. Simon's spoke of loud music in her neighborhood at all hours of the night, Mayor Washington encouraged her to contact the police department when that is happening.

<u>Rod Miller of W. Broadway</u> asked when his block would be deem historic and included in the historic district. Mayor Washington said council has not discussed moving in that direction, as it could become costly to homeowners to adhere to the Historic Preservation rules and regulations.

<u>Heather Ashfield of Chestnut St.</u> asked if the city would be having another city wide clean up soon. Councilman Groce referred her to Councilman Johnson as he is the chairman of that committee.

With no further requests for public comment, Councilman Groce made a motion to close the Public Portion of the meeting. Councilman Waddington seconded the motion and all were in favor. Councilman Waddington motioned to convene into Executive Session, Councilman Groce seconded the motion and all were in favor. The regular portion of the meeting ended at 7:46pm.
