A meeting of the Common Council of the City of Salem was called to order by Council President Karen Roots. The meeting took place at 1 New Market Street at 6:30 p.m. The meeting was opened with the Pledge of Allegiance. **Present**: Councilpersons Ruth Carter, William Corbin, Earl Gage, Timothy Gregory, Vaughn Groce, Sharon Kellum, and Council President Karen Roots. Also in attendance, Mayor Charles Washington Jr., Andrea Rhea-City Solicitor, Dave Crescenzi-CFO, and City Administrator/Clerk Ben Angeli. Councilman James Smith was absent.

COMMUNICATIONS/APPLICATIONS/REPORTS:

Presentation to the Director of ARC of Salem County by Mayor Washington and Council President Roots. Director Patty Irwin introduced Tommy McCarthy and Patricia Alston from ARC. She thanked Senator Sweeney for his support and then spoke about some of the ARC programs. She mentioned the thrift shop which serves as an anchor store for the city and the group home that has operated since 1980. She talked about how the home serves 22 people with adult training and living skills education. She also mentioned their meals on wheels, drop in Saturday program and the mobile crew that does grass cutting and cleaning at the library. She thanked Councilwoman Ruth Carter for her support.

New Jersey State Senate President Stephen M. Sweeney then spoke about the great work ARC does and that it is special to him because of his daughter. He spoke about how ARC helps people with disabilities lead happy healthy lives and how the organization helps hundreds of people. He thanked the governing Body for honoring ARC and stated that Salem City is a good community with lots of room to grow and a positive future.

CITY OF SALEM ORDINANCE NO. 1906

ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS OR PURPOSES BY THE CITY OF SALEM, IN THE COUNTY OF SALEM, NEW JERSEY, AND APPROPRIATING \$80,000 THEREFOR FROM THE CAPITAL IMPROVEMENT FUND OF THE CITY.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SALEM, IN THE COUNTY OF SALEM, NEW JERSEY, AS FOLLOWS:

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by the City of Salem, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the sum of \$80,000 from moneys available in the Capital Improvement Fund of the City.

Section 2. The improvements hereby authorized and the purposes for which said appropriation is made as provided in Section 1 of this ordinance include (i) the acquisition of various equipment including one (1) police car (\$31,000), one (1) recycling compactor (\$18,000), one (1) housing officer vehicle (\$10,000), fire equipment (\$5,000), ambulance equipment (\$5,000) and cameras for the Municipal Annex (\$5,000), (ii) the upgrade of the finance and tax collection computer equipment (\$3,000) and (iii) the resurfacing of the parking lot at the City Hall Annex (\$3,000), together with for all the foregoing all equipment, attachments, accessories, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the specifications therefor on file or to be filed in the office of the City Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the City Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.

CITY OF SALEM ORDINANCE NO. 1907

AN ORDINANCE OF THE CITY OF SALEM AMENDING SECTION 2 OF CHAPTER 43 OF THE MUNICIPAL CODE OF THE CITY OF SALEM FIXING THE TITLES, SALARIES AND COMPENSATION RANGES OF OFFICERS AND EMPLOYEES OF THE CITY OF SALEM

BE IT ORDAINED by the Common Council of the City of Salem, in the County of Salem and State of New Jersey that Section 2 of Chapter 43 of the Municipal Code as last amended by Ordinance 1307 and 1622 be amended as follows:

SECTION 1.

This ordinance sets the minimum and maximum salaries (listed in <u>Attachment A</u>) for the non-contractual officers and employees of the City of Salem, Salem County, State of New Jersey, in accordance with the provisions of this Ordinance, as set forth below to be effective upon adoption.

SECTION 2. Collective Bargaining Units

Salaries, remuneration, allowances and expenses as may be provided for by any Collective Bargaining Agreement or Employment Agreement approved by the Common Council of the City of Salem shall be paid in accordance with said agreement(s).

SECTION 3. All ordinances or parts of ordinances or any resolutions of the City of Salem inconsistent herewith are repealed in full.

SECTION 4. If any part or parts of the Ordinance are for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately after final passage and publication as provided by law.

AN ORDINANCE OF THE CITY OF SALEM AUTHORIZING THE TRANSFER OF PROPERTY IDENTIFIED AS BLOCK 68, LOT 42, 61 UNION STREET, SALEM, NJ TO SALEM FIRST PRESBYTERIAN CHURCH

WHEREAS, the City of Salem is the owner of certain property situate in the City of Salem identified as Block 68, Lot 42 upon the tax maps of the City of Salem, and commonly known as 61 Union Street Salem, Salem County, New Jersey; and

WHEREAS, the City desires to convey the aforesaid property to the organization known as Salem First Presbyterian Church, in accordance with the Local Lands and Buildings Law, N.J.S.A. 40A:12-1 et seq. so that the property becomes part of the expansion of a community Garden Project; and

WHEREAS, the sale of the property has been approved for the sum of \$10,500.00 by resolution of the City Council.

NOW, THEREFORE BE IT ORDAINED by the Common Council of the City of Salem that:

Section 1. The City of Salem be and is hereby authorized in accordance with the provisions of the New Jersey Local Lands and Buildings Law, N.J.S.A. 40A:12-1 *et seq.* to transfer property designated as Block 68, Lot 42, on the tax map of the City of Salem, commonly known as 61 Union Street, Salem, in the County of Salem and State of New Jersey.

- **Section 2.** The property is no longer needed by the City and is being transferred to the Church, a non-profit organization for the purpose of incorporating the property into a community garden project.
- **Section 3.** The Mayor is authorized to execute an agreement of sale in a form consistent with the intention of this Ordinance.
- **Section 4.** Transfer of the property shall be accomplished by deed for \$10,500.00 consideration and the Mayor is authorized to execute an agreement of sale and deed for the same.
- **Section 5.** If a court of competent jurisdiction shall declare any section, paragraph, subsection, clause or provision of this Ordinance invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.
- **Section 6.** All ordinances or parts of ordinances of the City of Salem heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of any inconsistency.
- **Section 7.** This ordinance shall take effect immediately upon final passage. Notice of the adoption shall be published as provided by law.
