#### ADMINISTRATION (Gage, Gregory, Kellum, Smith)

Council President Gage spoke about the importance of Council training and that it had not been done in years. He spoke about the WIPA process and named the people that would be on the WIPA Ad Hoc Committee (Mayor Washington, Gage, Groce, Gregory, Nunez, Angeli, Rhea and Representatives from R&V).

#### **PUBLIC SAFETY** (Gage, Smith, Groce, Davis)

Mr. Gregory was invited to speak about the "Coalition for a Safe Community". he mentioned the people and organizations that were involved. Mr. groce spoke about the Peace Task Force. Mr. Davis said that Council should be proactive. He spoke about loitering and the need for public transportation in the City.

#### PUBLIC WORKS (Groce, Gregory, Gage, Slaughter)

Mr. Angeli gave an update on the three street issues (9<sup>th</sup> Street, Pledger and Belden). Mr. Groce spoke about the WIPA process and the meeting with Mr. Ramsey.

#### ORDINANCE/BUILDINGS AND GROUNDS (Slaughter, Cline, Smith, Groce)

Councilwoman Cline spoke about the need to set smart goals and wanted the Council to look into renovating the football field. Mr. Angeli spoke about the committee putting a list of ordinances to look at for 2021. Mr. Groce mentioned working on a loitering Ordinance. The Solicitor stated that the Municipalities cannot do ordinances if the state criminal code addresses it. Chief Pelura stated that a loitering Ordinance may affect those that are not involved in criminal activity.

#### NEIGHBORHOOD INITIATIVES/PARKS AND RECS (Slaughter, Kellum, Cline, Davis)

Discussion about the possibility of a new park and what needed to be done at the City pool.

#### ECONOMIC AND COMMUNITY DEVELOPMENT (ECDC) (Smith, Davis, Kellum, Gregory)

Developing a list of properties for public auction and recreational Cannabis were discussed. The Mayor spoke about the NTI program and about the focus being on home ownership. Discussion ensued.

#### **CFO REPORT:**

Ms. Nunez said that she was working on closing out 2020 and putting all the information into the Edmonds system. Spoke about the 2021 budget and said that we should look at March 20<sup>th</sup> for introduction.

#### ADMINISTRATOR REPORT:

Mr. Angeli spoke about the NJDOT grant and that it would be on for the next meeting.

#### **COMMERCE DEPARTMENT:**

Discussion about the grant opportunity for a camera for illegal dumping.

WHEREAS, the former owner of property located on Griffith Street and designated as Block 3, lot 23, filed tax appeals for tax years 2015, 2016 and 2017; and

WHEREAS, a settlement was reached in the Tax Court of New Jersey and judgment reducing the assessment for tax year 2017 for the above referenced property was entered under Docket No. 005015-2017; and

WHEREAS, as a result of the settlement, the parties agreed that the overpayment in the amount of \$34,150.00 would be refunded without interest if made within 60 days of the entry of the judgment; and

NOW, THEREFORE BE IT RESOLVED by the Common Council of the City of Salem that a refund is authorized and shall be issued in accordance with the settlement reached in the tax appeal referenced above in the amount of \$34,150.00 to Bruce J. ## A RESOLUTION AUTHORIZING SALEM CITY COMMERCE DEPARTMENT TO PREPARE AND SUBMIT APPLICATION FOR THE CAMERA GRANT FOR ILLEGAL DUMPING

WHEREAS, the City of Salem desires to submit a proposal requesting that a camera or cameras be made available to the City to combat the illegal dumping that is prevalent in the City.

NOW, THEREFORE, BE IT RESOLVED, that the Common Council of the City of Salem, in the County of Salem, New Jersey hereby authorizes the Salem City Commerce Department to prepare and submit the application for the NJDEP Camera grant for Illegal Dumping.
