Mr. Gage stated that there would be a meeting on Wednesday night with SUFS executive Board. A Committee meeting was also scheduled to discuss the LEAP grant. Mr. Davis spoke about the letter that Council received in the mail from a resident with concerns about crime in the City. He said we had to do better and things needed to change. Mr. Groce said that is why we have a plan.

PUBLIC WORKS (Groce, Gregory, Gage, Slaughter)

Mr. Liu gave a presentation on Well #8. Mr. Angeli said that interviews were scheduled for this week and the plan was to hire two new laborers. The departments would also be submitting capital improvement plans.

ORDINANCE/BUILDINGS AND GROUNDS (Slaughter, Cline, Smith, Groce)

Ms. Cline said that she emailed the Smart Goals out to everybody. She said that Mr. Bailey had reached out to Dr. Michel about the pool.

NEIGHBORHOOD INITIATIVES/PARKS AND RECS (Slaughter, Kellum, Cline, Davis)

Ms. Slaughter said that they were focused on clean-ups. She stated that she was ordering supplies and contacting the volunteers. She mentioned that the clean-up would be on front and Oak streets on 4/17. Mr. davis spoke about the basketball courts and that the contractor was donating the stripping. He said that he was going to hold a party when he courts were finished.

ECONOMIC AND COMMUNITY DEVELOPMENT (Davis, Smith, Gregory, Kellum)

Mr. Bailey said that he spoke to someone from NY hat was interested in a warehouse in the City.

MAYORAL COMMENTS:

Mayor Washington stated that the American Rescue Plan was passes by congress. The City would be getting \$462,000.00. Mr. gage said that he reached out to the State Monitor for direction on how we would receive the money and what we could do with it. The Mayor stated that Jack's Men's Store was in the final approval stages for demolition. He said that the special meeting would be for an ordinance required to restructure the financing on the Finlaw building. The Finlaw financing has been detrimental to the current City financial rating.

CFO REPORT:

Ms. Nunez talked about Ordinance 2102. Mr. Davis asked if we could get a report on the In rem properties.

COMMERCE DIRECTOR REPORT:

Mr. Bailey spoke about the auction that was held. He had Mr. Angeli send out a Eblast about the City housing program. He was working with the Solicitor to develop a plan for helping people get qualified. Mr. bailey said that he git nine good leads for the program. He was also working on a HUD program for the fall. He met the new Director for the Housing Authority. He was still waiting to hear about the CDBG program. Mr Davis stated that he wants to auction 20 homes ta the next auction. Mayor Washington stated that he had concerns about some of the bidders and about what they were going to do with the properties. He said we already had a high rental rate. He said we needed to clean up some things with the auction process. Mr. bailey agreed and said we needed to work on the lists of properties. Mr; Davis said that he spoke to some of the bidders and that they are planning on moving on to the properties. Mr. gage said that we needed to have the lists ready and set up autions for home owners only. The Mayor said that that was why the City had the NTI program. Mr, Groce agreed and stated that we did not have to reinvent the wheel.

CITY OF SALEM ORDINANCE NO. 2101

AN ORDINANCE OF THE CITY OF SALEM AMENDING SECTION 2 OF CHAPTER 43 OF THE MUNICIPAL CODE OF THE CITY OF SALEM FIXING THE TITLES, SALARIES AND COMPENSATION RANGES OF OFFICERS AND EMPLOYEES OF THE CITY OF SALEM

BE IT ORDAINED by the Common Council of the City of Salem, in the County of Salem and State of New Jersey that Section 2 of Chapter 43 of the Municipal Code as last amended by Ordinance 1307 and 1622 be amended as follows:

SECTION 1.

This ordinance sets the minimum and maximum salaries (listed in <u>Attachment A</u>) for the non-contractual officers and employees of the City of Salem, Salem County, State of New Jersey, in accordance with the provisions of this Ordinance, as set forth below to be effective upon adoption.

SECTION 2. Collective Bargaining Units

Salaries, remuneration, allowances and expenses as may be provided for by any Collective Bargaining Agreement or Employment Agreement approved by the Common Council of the City of Salem shall be paid in accordance with said agreement(s).

SECTION 3. All ordinances or parts of ordinances or any resolutions of the City of Salem inconsistent herewith are repealed in full.

SECTION 4. If any part or parts of the Ordinance are for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately after final passage and publication as provided by law.

CITY OF SALEM ORDINANCE 2102

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK FOR THE CALENDAR YEAR 2021 (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the City Council of the City of Salem in the County of Salem finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the City of Salem hereby determines that a 1 % increase in the budget for said year, amounting to \$ 70,448.71 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the City Council of the City of Salem hereby determines that any amount authorized hereinabove that is not appropriated, as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the City Council of the City of Salem, in the County of Salem, a majority of the full-authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the City of Salem shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$ 246,570.48 and that the CY 2020 municipal budget for the City of Salem be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
