### COMMITTEE REPORTS AND DISCUSSION:

ADMINISTRATION (Gage, Gregory, Kellum, Smith)

Mr. Gage said that Admin had some items that would be discussed in Executive Session.

PUBLIC SAFETY (Gage, Smith, Groce, Davis)

Mr. Gage complimented Mr. Bailey on his "Targeted Neighborhood Report". He stated that the Committee had a number of meetings and that they would be meeting with SUFS and others about the project.

PUBLIC WORKS (Groce, Gregory, Gage, Slaughter)

Mr. Groce spoke about putting together a list of vacant City properties that needed to be dealt with. He was asking for a capital needs lis from the departments. His Committee wanted to hire another person when the hiring process started. He said that the road to the sewer plant was in very bad shape.

ORDINANCE/BUILDINGS AND GROUNDS (Slaughter, Cline, Smith, Groce)

Mr. Angeli spoke about the roof at #1. Ms. Cline spoke about setting "Smart Goals" and especially a "Smart Goal" for the swimming pool. Discussion about getting a price for putting a cover on the #1 roof and getting estimates. The Solicitor spoke on some new regulations. The Library and the property at 116 W. Broadway was brought up and it ewas explained that no final agreement had been drawn up for the Library to control that property. The Solicitor said that she had a final draft. Ms. Cline spoke about the library finances. Mr. Davis asked about the salary of the Librarian. Civil Service was discussed in reference to the library positions. Ms. Cline spoke about the condition of the buildings and grounds.

### NEIGHBORHOOD INITIATIVES/PARKS AND RECS (Slaughter, Kellum, Cline, Davis)

Ms. Slaughter spoke about the clean-up dates and said that she had dumpsters scheduled and would be supplying box lunches for the workers. She said that she already had a lot of groups signed up. Sharen Cline said that she would be working on the educational projects for Clean Communities. Mr. Davis spoke about the basketball courts and asked that the piles of mulch be moved.

### ECONOMIC AND COMMUNITY DEVELOPMENT (ECDC) (Smith, Davis, Kellum, Gregory)

Mr. Smith spoke about the new Cannabis legislation.

### **MAYOR'S COMMENTS:**

Mayor Washington spoke about meetings about crime in the City and meeting with the State Police. He said that there was a "Safe Communities Committee" meeting the next day. He spoke about creating some "safe streets". Ms. Cline asked if their work was in parallel to the City plan for targeted areas. The Mayor spoke about increasing City Pride.

#### CFO REPORT:

Ms. Nunez spoke about putting together the 2021 budget and said that the Transitional Aid Application was due in April.

### **ADMINISTRATOR REPORT:**

Mr. Angeli spoke about some of the agenda items that would be on for the next meeting. He encouraged people to sign up for the City Eblast.

### COMMERCE DIRECTOR REPORT:

Mr. Bailey did a power point presentation on the Quality of Life Initiative Presentation and answered questions from the Mayor and Council members. The number of rental properties in the City was brought up. Mr. groce spoke about the NTI program and asked if vetted landlords could be a part of the program.

**NOW, THEREFORE, BE IT RESOLVED,** by the Common Council of the City of Salem that the tax Collector refund tax overpayments or cancel delinquents in the amount of \$10.00 or less as deemed necessary without further action;

WHEREAS, on February 15, 2021 the Common Council adopted Resolution 2021-63 FIXING SALARIES OF CERTAIN CITY OFFICERS. EMPOYEES AND APPOINTEES; and

WHEREAS, the salary for the Tax Assessor for 2020 was listed incorrectly as \$21,804; and

WHEREAS, the salary for the Tax Assessor for 2020 should be \$22,131.06; and

WHEREAS, it is the intention of the Mayor and Council to fix the salary for the Tax Assessor.

**NOW, THEREFORE BE IT HEREBY RESOLVED** by the Mayor and Council of the City of Salem that the salary of the Tax Assessor be set at \$22,131.06 for 2020 and be subject to the salary ranges set forth in the aforementioned ordinance and is hereby fixed effective January 1, 2020.

# A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, NJSA 10:4-12 These items are for

(#7) Matters relating to litigation, negotiations and attorney-client privilege (#8) Matters relating to the employment relationship

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12b permits a public body to go into a closed session during a public meeting to discuss certain matters as follows:

(1) Matters Required by law to be confidential: Any matter which by express provision of the Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

(2) Any matter in which the release of information would impair the right to receive federal funding.

- (3) Matters involving individual privacy: Any matter, the disclosure of which constitutes an unwarranted invasion of individual privacy such as records, data, reports, recommendations or other personal material of any education, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including, but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned.
- (4) Matters pertaining to a collective bargaining agreement: Any matter involving a collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
- (5) Matters relating to the purchase, lease acquisition of real property or investment of public funds: Any matter involving the lease, purchase or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.
- (6) Matters of public protection: Any tactic and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection.
- (7) Matters relating to litigation, negotiations and attorney-client privilege: Any matter of pending or anticipated litigation or contract negotiation other than in (4) above in which the Board is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required for the attorney to exercise ethical duties as a lawyer.
- (8) Matters relating to the employment relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all of the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed in public.
- (9) Deliberations after public hearing. Deliberations by the Board occurring after a public hearing that may result in a civil penalty or the suspension or loss of a license or permit of a responding party; and

WHEREAS, the City Council has determined that it is necessary to go into a closed session to discuss certain matters relating to the items as permitted by N.J.S.A. 10:4-12b

**NOW, THERFORE BE IT RESOLVED,** by the City Council of the City of Salem that the Council will go into closed session to discuss the following, in accordance with the aforesaid provisions of the Open Public Meetings Act, after which it will reconvene in the public:

(#7) Matters relating to litigation, negotiations and attorney-client privilege

(#8) Matters relating to the employment relationship
