ANGEL INVESTOR TAX CREDIT PROGRAM

Offers tax credits against corporation business or gross income taxes based on a qualified investment in a New Jersey emerging technology businesses for the purposes of stimulating investment, www.nieda.com/angeltaxcredit/



ASPIRE PROGRAM

Provides gap financing to support commercial, mixed-use, and residential real estate development projects. www.njeda.com/aspire



BOND FINANCING

Provides eligible creditworthy manufacturing companies, 501(c)(3) not-for-profit organizations, and exempt facilities in NJ may with long-term financing. www.njeda.com/bondfinancing/



BROWNFIELDS IMPACT FUND

BROWNFIELDS LOAN PROGRAM

NEW JERSEY MANUFACTURING VOUCHER PROGRAM

The New Jersey Manufacturing Voucher Program is a \$20,000,000 pilot grant program to assist New Jersey Manufacturers with accessing the manufacturing equipment they need to become more efficient, productive, and profitable. CDFI LOAN TO LENDER PROGRAM

Provides financing to qualified Community Development Financial Institutions (CDFIs), for the purposes of administering term loans or lines of credit to qualified micro-enterprises and small businesses, some of which may not be able to secure traditional bank financing. www.njeda.com/cdfiloantolender/



DIRECT LOANS

Provides eligible New Jersey businesses in need of financing and committed to job creation and retention with direct loans when conventional financing is not available.

EDISON INNOVATION FUND

Offers a suite of financing instruments designed to develop, sustain, and grow technology and life sciences businesses in New Jersey. EMERGE PROGRAM

Encourages economic development in Governor Phil Murphy's priority sectors and in targeted communities across the New Jersey. The program provides per-job tax credits to projects that invest private capital into the state and create new good-paying jobs (or retain a large number of good-paying jobs). www.njeda.com/emerge/



FILM & DIGETAL MEDIA TAX CREDIT PROGRAM

Provides a transferable credit against the corporation business tax and the gross income tax for qualified expenses incurred for the production of certain film and digital media content in New Jersey. www.njeda.com/film/



FOOD SECURITY PLANNING GRANT

Awards grants of between \$75,000 to \$125,000 to municipal governments, county governments, and/or redevelopment agencies to improve food access and food security by leveraging distressed assets in New Jersey's Food Desert Communities. www.njeda.com/food-security-planning-grant/



HAZARDOUS DISCHARGE SITE REMEDIATION FUND (HDSRF)

Businesses operating in New Jersey, individuals, or municipalities that are required to, or volunteered to, perform remediation and/or cleanup of contaminated and underutilized sites may be eligible to secure financing through loans and/or grants. www.njeda.com/hdsrf/



HISTORIC PROPERTY REINVESTMENT PROGRAM

Provides competitive tax credit program to leverage the federal historic tax credits to support the rehabilitation projects of identified historic properties.

Provides grants up to \$125,000 for the preparation of Historic Property Surveys throughout the state that include within the defined scope, properties located within a Government Restricted Municipality or that would be considered distress asset/s.

MAIN STREET MICRO BUSINESS LOAN PROGRAM - COMING SOON

Provides financing up to \$50,000 to businesses with annual revenues in the most current fiscal year of no greater than \$1,500,000, and 10 full-time employees or less at time of application. Financing can be used for inventory, purchase of equipment, or working capital. Ten percent of the approved loan amount may be forgiven, if applicable. www.njeda.com/microbusinessloan/





NJ ACCELERATE

SALES AND USE TAX EXEMPTION PROGRAM

Provides eligible companies with 1,000 or more employees making purchases for construction and renovation of a new location with a sales tax exemption certificate for purchases of machinery, equipment, furniture and furnishings, fixtures and building materials for placement at the project location until the new facility is functional. www.njeda.com/stx/



SMALL BUSINESS BONDING READINESS ASSISTANCE PROGRAM

SMALL BUSINESS FUND

Offers assistance to eligible creditworthy small, minority-owned or women-owned business in New Jersey in operation for at least one full year who may not have the ability to get bank financing, or not-for-profit corporation in operation for at least three full years. www.njeda.com/smallbusinessfund/



SMALL BUSINESS IMPROVEMENT GRANT

Offers reimbursement for costs associated with making building improvements or purchasing new furniture, fixtures and equipment. www.njeda.com/small-business-improvement-grant/



SMALL BUSINESS LEASE GRANT

Supports the growth and success of small businesses and nonprofits by providing grant funding to cover a portion of lease payments for businesses and nonprofits leasing new or additional space. www.njeda.com/small-business-lease-grant/



SUSTAIN AND SERVE NJ

TECHNOLOGY BUSINESS TAX CERTIFICATE TRANSFER (NOL) PROGRAM

Enables qualified, unprofitable New Jersey-based technology or biotechnology companies with fewer than 225 US employees (including parent company and all subsidiaries) to sell a percentage of net operating losses (NOL) and research and development (R&D) tax credits to unrelated profitable corporations. www.njeda.com/nol/



URBAN ENTERPRISE ZONE (UEZ) MANUFACTURERS ENERGY SALES TAX EXEMPTION

Urban Enterprise Zone (UEZ)-certified manufacturers that employ at least 250 full-time workers, at least 50% of whom are involved in the manufacturing process, may be eligible for an exemption from the sales and use tax for electricity and natural gas utilities, both the commodity and its transmission, consumed at the UEZ-certified location. www.njeda.com/uez/
