- 1. Andrea Rhea, Esq., an attorney at law licensed to practice in the State of New Jersey, be and is hereby appointed to serve as Municipal Prosecutor for the City of Salem for the calendar year 2022.
- 2. The Mayor and Clerk are authorized and directed to execute an agreement for professional services with the Municipal Prosecutor who shall be paid in accordance the same.
- 3. This contract is awarded without competitive bidding as a professional service pursuant to the Local Public Contracts Law
